## 1 DOL

U.S. Company obtains prevailing wage from DOL.

## 2 PERM

U.S. Company files labor certification form 9089 with DOL.

## 3 I-140

U.S. Company files the form with USCIS.

## 4 I-485

Foreign employee files the form with USCIS.

1. Create Account & Submit Form: Create an account on [bhsigroup.com](http://bhsigroup.com) and submit your form.
2. Check Eligibility: Verify your eligibility for EB-3 through your dashboard.
3. Client-Employer Matching: Get matched with a suitable employer.
4. Accept Job Offer: Accept the job offer provided by the employer.
5. PERM Labor Certification: Employer applies for PERM Labor Certification (Form 9089) from the DOL.
6. File Form I-140: Both applicant and employer file Form I-140 with USCIS for approval.
7. Submit Visa Application: Pay fees and submit the visa application.
8. Consulate Interview: Attend an interview at the U.S. consulate.
9. Visa Issuance: Receive your Permanent Resident Visa upon approval.
10. Arrival and Onboarding: Arrive in the USA, obtain your green card and SSN, and start working.

### EB-3 Green Card Processing Time: The Only Guide You Need

Many individuals come to the United States to work temporarily on nonimmigrant visas, while others desire to make it their permanent home. Immigrant visas, often known as green cards, enable foreign workers to reside and work in the United States for up to 10 years. Because of its modest criteria, the EB-3 green card is one of the most popular types of green cards sought. However, because it is a popular green card, the time it takes to receive one might be affected.

What is EB-3 Visa?

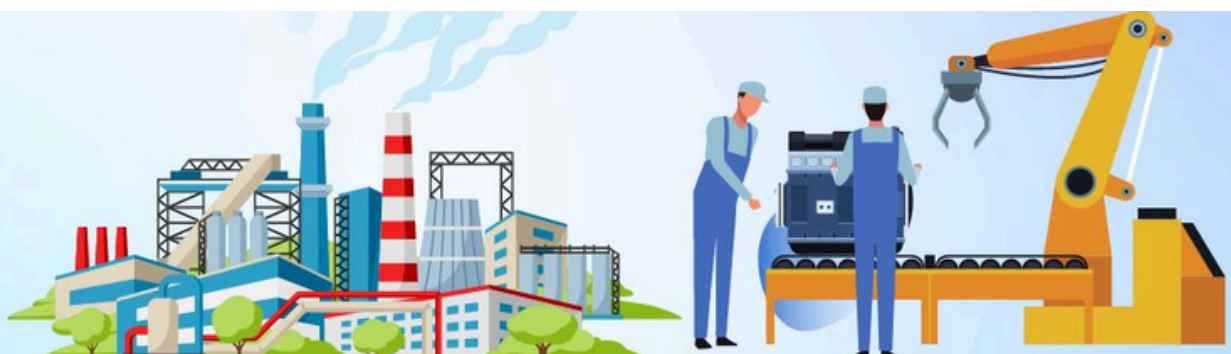
EB-3 visa is an employment-based immigrant visa that allows skilled workers, professionals, and even unskilled workers to obtain a green card based on a full-time job that is not of temporary or seasonal nature.

The EB-3 visa makes up 28.6 percent of the employment-based green cards available for overseas workers. Around 40,000 of these visas are available every year. Furthermore, no more than 7% of all EB3 visas can be granted to citizens of any one country.

### EB-3 Visa Requirements:

The EB-3 visa for unskilled workers (other workers) is less stringent compared to the EB-1 and EB-2 visas. High degrees, exceptional skills, or highly qualified resumes are not necessary. If you meet the following requirements, you can apply for an EB-3 visa as an unskilled worker:

**Qualifications:** You must be capable of performing unskilled labor, which does not require specific educational or experience prerequisites.



# EB3 Green Card Processing Time

## EB-3 Visa Process Steps

EB-3 visa processing involves four major steps. These steps include:

Step 1: PERM Labor Certification

Step 2: I-140 Petition

Step 3: Wait for Priority Date

Step 4: Adjustment of Status or Consular Processing Each step has a different documentation requirement and processing time.

## EB3 Estimated Processing Times:

1. Labor Certification: 6-12 months

2. Form I-140: 6-9 months

3. Priority Date Waiting Time: Varies (depending on country of origin and visa category)

Adjustment of Status (Form I-485): 8-14 months or Consular Processing: 6-12 months

## Payment Plans Available

### First payment

Shall be paid to BHSL upon commencement of BHSL's consulting and administrative services.

### Third Payment

Shall be paid in full to BHSL within 14 (days) upon receipt of I-140 approval notice.

### Fourth payment

Shall be paid in full to BHSL upon receipt notice of the immigrant visa interview at the US Consulate.
